Who is providing this notice?	NTA Life is a Horace Mann company and provides this notice because we are serious about our commitment to your privacy. This notice also applies to our affiliates.
What we do	
How does NTA Life protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We limit access to your information to those people who need it to perform their jobs. Misuse of your information by employees will result in discipline.

Can I request to access, correct, amend, or delete the personal information NTA Life has on me?	<p>Upon request, you have the right to receive and review a copy of your information, and to ask us to correct, amend, or delete recorded personal information.
